The Government of Suriname has received financing from the Islamic Development Bank toward the cost of the Secondary and Technical Education Support (STES) Project and intends to apply part of the proceeds for consultant services.

The services include capacity building for the key-staff of the Information and Communication Technology (ICT) department of the Ministry of Education Science and Culture for a period of 10 months from the date of contract signing. The Ministry of Education, Science and Culture now invites eligible **Individual Consultants** to indicate their interest in providing the services. Interested Consultants must provide specific information which demonstrates that they are fully qualified to perform the services (description of similar assignments (minimum of 3), experience in similar conditions, availability of appropriate skills, etc.).

The shortlisting criteria are:

General qualifications

A degree in Computer Science (BSc) or equivalent is preferred.

Adequacy of the Consultant's expertise and experience for the assignment

The consultant must be skilled and experienced for setting up a technically robust and educationally performant ICT system. He/she should also have demonstrated capacity in software, hardware, and networks to organize the department and provide and organize assistance to end users.

The consultant should have demonstrated capacity to provide the required expertise in coordinating and training in ICT related subjects as stated in the objectives described in the ToR under paragraph 2.

The consultant must be experienced in working with Microsoft Server 2016 and thin clients.

The consultant should have expertise in setting up and maintaining Moodle-based learning environments.

The consultant should have expertise in setting up and maintaining Microsoft 365 environments.

Experience in the sector

The consultant should have demonstrated affinity with ICT in Education.

Experience in the region and Language

The consultant should have knowledge of the Surinamese educational system and experience in Suriname.
