The Government of Suriname has received financing from the Islamic Development Bank (IsDB) toward the cost of the Secondary and Technical Education Support (STES) Project and intends to apply part of the proceeds toward payments under the contracts for Purchase of Equipment for ICT labs, laptops and network printers for Ministry of Education, Science and Culture.
2. The Ministry of Education, Science and Culture now invites sealed bids from eligible bidders for the Purchase of Equipment for ICT labs, laptops and network printers which will be carried out in three lots. The supply and installation period is 4 (four) months after contract signature.
3. Bidders may bid for one or several contracts, as further defined in the bidding document. Bidders wishing to offer discounts in case they are awarded more than one contract will be allowed to do so, provided those discounts are included in the Letter of Bid.
4. Bidding will be conducted through the National Competitive Bidding procedures as specified in IsDB's Guidelines: Procurement of Goods, Works and related services under Islamic Development Bank Project Financing (current edition: April 2019/Revised February 2023 – www.isdb.org), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.18 -21 setting forth IsDB's policy on conflict of interest.
5. Interested eligible bidders may obtain further information from Project Coordination Unit and inspect the bidding documents at the address below during office hours 8:00 -16:00 hours local time, Monday-Friday.
6. A complete set of bidding documents in English may be purchased by interested eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of USD 25. The method of payment will be a direct deposit to the Project USD Account number 0313100-001-118-840 at the Central Bank of Suriname. After receipt of the written application accompanied by a deposit receipt, the bidding document can be picked up on a CD or can be emailed to the interested eligible bidders.
7. Bids must be delivered to the address below on or before July 25, 2023, by 14:00 hours. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on July 25, 2023, by 14:05 hours.

8. All bids must be accompanied by a Bid Security as stated below:
- USD 4.000,00 (Four Thousand 00 / 100 Unites States Dollars) for lot 1;
 - USD 3.000,00 (Three Thousand 00/ 100 Unites States Dollars) for lot 2 and
 - USD 400,00 (Four Hundred 00 / 100 Unites States Dollars) for lot 3.
